- d. Applicants for REALTOR<sup>®</sup> membership shall be granted provisional membership immediately upon submission of a completed application form and remittance of applicable dues and fees. Provisional members shall be considered REALTORS<sup>®</sup> and shall be subject to all of the same privileges and obligations of membership. Provisional membership is granted based upon the individuals' application in which he/she affirms that the information provided is true and accurate.
